Motion to Open the Meeting was made. This Motion was seconded and with 7:00 vote passed at 7:04 PM.

Kevin Witzell began a presentation on the proposed plans for the project. Jennifer discussed a meeting with the Library Trustees regarding their requests for additional storage in the new construction.

Kevin handed out preliminary plans of room layouts and area needs for various departments. He discussed how he interviewed department heads to get better feedback of their requirements. The plans are based on their feedback. Kevin discussed how departments would be placed adjacent to one another and also how various departments should be located based on the needs of the public to access on a daily basis.

Jesse and Justin discussed how we should plan for the future and for future growth.

Kevin discussed his need for guidance from the Members as to the style of the building, growth potential and stay within the budget. He sees the public safety departments as needing to plan for the greatest growth with population growth versus growth requirements of administration departments. Andrea and Jennifer discussed that administrative personnel needs may actually decrease in the future with developing technology and document storage methods. Personal services such as police, fire and parks will likely require more resources with a bigger population.

Kevin and Justin discussed a possible outbuilding to be used for vehicle maintenance and storage of equipment or possibly documents. Little used equipment doesn't need to be using up valuable space within the new public safety building. Justin also discussed saving money by moving the fuel tank equipment and tank from the current location to the new location.

Kevin began his presentation of the power point. Four options for building layout were presented with various options for locations of buildings and access and egress to South Street.

Option 4 which places town hall closer to the library and a driveway to the left of both buildings seems to be preferable to the Members. Separate access is provided for public safety along the current driveway.

Jesse and Luke discussed the need to vote on the possible re use of the school building. Kevin's engineer will provide a definite recommendation on this issue. Jesse discussed the need to get this issue to town meeting.




